2. Subject of the Agreement

1. The Provider agrees to provide accommodation and full board catering services for participants of the Erasmus+ mobility project organized by the Customer (Agreement number: 2025-1-SK01-KA121-VET-000321633). Accommodation shall be provided at Student Residence, C.Carril 8, Distrito Centro, Málaga, Spain
2. Services shall be provided for:
 - 16 students
 - 2 accompanying teachers

Duration of stay:
from 27/07/2026 to 10/08/2026
3. Place of accommodation:

Accommodation in Malaga. Full Board - 14 nights, 16 students and 2 accompanying teachers

5. The services include:

- accommodation,
- meals (full board); Full board includes breakfast, lunch and dinner throughout the stay.,

The services shall be provided for participants listed in Annex 1 of this Agreement.

3. Price and Payment Terms

1. The total agreed price for the service is: **20 279,84EUR**
 - The price includes all services specified in Article 2 of this Agreement.
 - The Provider shall issue an invoice to the Customer.
 - The invoice maturity period shall be 14 days from the date of issue.
 - Payment shall be made by bank transfer to the Provider's bank account.

4. Rights and Obligations of the Parties

The Provider agrees:

- to provide invoices and supporting documentation related to the services provided,
- to provide the agreed services in proper quality and scope,
- to comply with applicable safety and hygiene regulations,
- to inform the Customer without delay about any important circumstances affecting the stay.

The Customer agrees:

- to provide necessary cooperation,
- to pay the agreed amount properly and on time,
- to ensure that participants comply with accommodation rules.

5. Cancellation Terms

1. In case of cancellation by the Customer, the following cancellation fees apply:
 - more than 30 days before arrival: no cancellation fee,
 - less than 30 days before arrival: cancellation fee of 50 %.
2. Both parties may agree on individual conditions depending on Erasmus+ project circumstances.

6. Final Provisions

1. This Agreement enters into force on the date of signature by both parties.
2. If required by Slovak legislation, the Agreement becomes effective after its publication in the Central Register of Contracts.
3. This Agreement is made in two identical copies, one for each party.
4. Both parties declare that they have read and understood this Agreement and sign it voluntarily.
5. Annex 1 (List of Participants) forms an integral part of this Agreement.
