Now therefore, is agreed the following terms and conditions:

### Article 1 – Contract object

The Sending Organization **Stredná odborná škola** requires the Service Provider to **organize an internship stay for 17 STUDENTS and 2 teacher/leaders recruited by the Sending Organization from 4.3.2018 to 22.3.2018.** Name of the project: Kvalitné vzdelanie – základ úspešnej budúcnosti, 2017-1-SK01-KA102-035052

The internship stay organized by Service provider includes::

1. Internship work placement fee for the students
2. Pick up from / to the train station
3. Accommodation for students in twin and triple rooms, Half Board (breakfast and dinner) for 17 students for 18 nights.
4. Accommodation for 2 leaders in single rooms, half board (breakfast and dinner) for 18 nights
5. Local public transport (1 month pass) for all participants and the leaders
6. Guided tour in the Prague Castle and Prague centre with a professional guide
7. Škoda Auto Excursion by rented coach
8. Technical museum visit
9. Entry to the museum or another activity according the wish (max 10,- EUR per person)
10. River cruise 3 hours with dinner on the boat
11. Laser game
12. One day trip to Karlovy Vary by rented bus – included the entry to the Becherovka museum – weekend trip
13. Safety pass training
14. Monitoring and follow up of the group

**Lunches for the group are not included in the budget, School will give money for lunches directly to the participants of the project before their departure to Prague.**

### Article 2 – Additional service

Any additional service which is not provided in the agreed contract will give rise to an extra invoice.

Requests for extra services must be sent to the Service Provider **in time** before the group arrival and must be both sides confirmed. Payment for extra activities must be paid before the group arrival.

### **Article 3 – Parties engagement**

#### ***The Service Provider engages to:***

1. Organize a program according to the requirements of the sending organization.
2. Provide details of the accommodation and a detailed program of the visits minimum 1 week before the expected date of student's arrival if the Sending Organization has provided all the information in time.
3. Provide, where possible, any additional service requested for by the Sending Organization.
4. Welcome students on their arrival at the station in the host country and accompany them during the excursions and trips if applicable.
5. Ensure the students' regular follow up.
6. Assist students with any administrative formalities within the host country.
7. Undertake quality control regarding the stay and provide the information to the Sending Organization.

#### ***The Sending Organization engages to:***

> Provide all the required information **in time** before the expected date of student's arrival regarding:

- The exact content of the program and the students list
- The description of the students' field of vocational training
- Details of Additional services requested
- Individual and group medical insurance certificates including the insurance for a work abroad. Also liability insurance required.

> Ensure the validity of the students' ID or passports and visa.

### **Article 4 – Civil and medical insurance certificate**

The Sending Organization engages to provide the Service Provider with a copy of the individual medical insurance certificates as well as the insurance of the whole group which covers students for the work placement in the Czech Republic. We need also liability insurance for group.

### **Article 5 – Price**

For the service provided, the Sending Organization shall pay the Service Provider agreed price which is **28.093,50 EUR**:

The service provider will issue 1 invoice.

### **Article 6 – Payment conditions**

The Sending organization undertakes the responsibility to pay the Service Provider, 100% of the total amount of the price on or before **2 weeks before the group arrival**.


The due date of the invoice will be written on the invoice.

The Sending Organization shall pay the invoice by bank transfer SWIFT.

A penalty will be imposed for a late payment, and it is calculated at a rate of 0,1 % for each day after payment due date.

### **Article 7 – Confidentiality clause**

Parties engage to respect the strictest confidentiality regarding any part of this contract and the service provided.





## **Article 8 – Accommodation Cancellation Policy**

If the Sending Organization cancels the accommodation:

30 - 21 days before the arrival the Sending Organization will be charged 20% of the total price of the accommodation.

20 - 10 days before the arrival the Sending Organization will be charged 50% of the total price of the accommodation.

9 - 4 days before the arrival the Sending Organization will be charged 70% of the total price of the accommodation.

3 days before the arrival or "no show" the Sending Organization will be charged 100% of the total price of the accommodation

## **Article 9 – Termination clause**

In case the contract is cancelled by the Sending Organization for reasons justified or unjustified after the Service Provider commences the organization of a stay and internship research, the Sending Organization agrees to pay to the Service Provider 50% of the Internship placement fee.

If the mentioned fees above have not been paid, the Sending Organization guarantees the payment within 2 weeks after receiving the invoice from the Service Provider.

If the received payment is higher than total of the cancellation fees, then the difference will be returned to the Sending Organization's bank account within 2 weeks of the cancellation of the internship stay.

Termination and the cancellation fees of the accommodation see the Article 8.

## **Article 10 – Student Behavior**

Under no circumstances, shall the Service Provider shall be held responsible for any difficulties arising from students' behavior. Students shall be held personally accountable for any actions civil or legal. The Service Provider reserves the right to send them back to their country of origin in the event of unacceptable behavior.

## **Article 11 - Damage to Property and Refundable Deposit**

The Sending Organization will inform the group leaders and the school management that **each student is supposed to pay in a hotel a refundable deposit of 30 Euro**. This refundable deposit will be kept in the hotel safe and used for possible damage caused by the students. In case that no damage will incur, the deposit will be returned to the students in full.
